I **Beryl Anne Taylor** of "Newlands", 6 Hoburne Lane, Higheliffe, Christchurch, Dorset BH23 4HP revoke all my previous testamentary dispositions and declare this to be my last Will.

1. Declaration

- 1.1. I declare, for the avoidance of any doubt, that although my husband Frank Edward Taylor ("Frank") is making a Will in terms similar to this Will the two Wills are not intended to be mutually irrevocable.
- 1.2. Both Frank and I are free to amend the terms of our Wills at any time without reference to the other.

2. Funeral wishes

I wish my body to be cremated.

3. Appointment of executors and trustees

- 3.1. I appoint my daughter Susan Anne Brougham ("Susan") and my son Stephen Frank Taylor ("Stephen") to be the executors and trustees of this Will.
- 3.2. In this Will and any Codicil to it the expression "my Trustees" means its trustees or (where the context requires) my personal representatives for the time being and shall include a sole executor and trustee.

4. Cash gift

I divide the sum of £120,000 equally between such of Susan and Stephen who survive me.

5. Residuary Estate

- 5.1. I give all of my estate which is not otherwise disposed of by this Will or any Codicil (after payment of my funeral, testamentary expenses, legacies, taxes and debts) ("my Residuary Estate") to Frank absolutely.
- 5.2. If Frank fails to survive me then I divide all of my Residuary Estate equally and absolutely between such of Susan and Stephen who survive me.
- 5.3. If either or both of Susan and Stephen dies before me leaving a child or children who reaches the age of 21 then that child or children shall be entitled (equally if more than one) to the share of my Residuary Estate which their parent would have taken.

6. Administrative provisions

- 6.1. The Standard Provisions of the Society of Trust and Estate Practitioners (First Edition) shall apply but so that paragraph 9 is deleted.
- 6.2. Any Trustee subject to fiduciary duties under my Will may:
 - 6.2.1. enter into a transaction with the Trustees; or

- 6.2.2. be interested in an arrangement in which Trustees are or might have been interested; or
- 6.2.3. act (or not act) in any other circumstances

even though his fiduciary duty under this Will conflicts with other duties or with his personal interest.

- 6.3. Section 31 of the Trustee Act 1925 shall apply except that throughout that section the age of 21 is substituted for the age of 18 and infancy shall mean the period before the age of 21 is reached.
- 6.4. Sections 11, 19 and 20 of the Trusts of Land and Appointment of Trustees Act 1996 shall not apply.
